April 29th; May 27th; June 17th
All meetings are held at 12 noon in the hospital classroom.

Department reporting QI Q2

April: Nursing; Respiratory; Pharmacy; Heritage

May: Radiology; Physical Therapy; Dietary; Social Services

June: Lab; Housekeeping; EMS

Department "Opportunity for Improvement"

Nursing: working on ways to improve documentation of the patient admission history. QI coordinator works closely and communicates with DON to get reminders to all nurses by way of email/meetings/one on one. Swingbed patients: Improvement made from Q1 -Q2 in the completion of "Interdisciplinary Team Meeting" form. Handwashing monitoring remains at 83% compliance.

Respiratory: new measure added beginning of Q1 for recovering "near miss" lost R.T. charges in the Emergency Room. New process: charge stickers for all respiratory supplies need to be placed on green cardstock card for each patient. Improvement has been reported by the R.T. Director from Q1 to Q2. Reports improvement from Q1 to Q2 in Handwashing monitoring.

Pharmacy: new quality measures added Q1. Unit inspections remain at 67% compliance. Issue has been identified per pharmacy tech's QI reporting. The P-D-S-A (plan, do, study, act) worksheet will be started to help guide in solving this issue.

Physical Therapy: physical therapy department met all benchmarks for Q1.

Dietary: dietary manager implemented the patient menu plan for the patients. Some improvement has been made from Q1 – Q2 in the inspection of the patient refrigerator/microwave/expired food, drinks, snacks. All dietary staff has renewed their Food Handler's Certificate.

Social Services: Manager reports 100% compliance Q2 for suicide risk safety plan.

QI coordinator will continue to monitor all Aspects of Care

Safety Reminders:

- -Liquid in trashcans: Please do not pour any type of liquid in the trash cans, especially a cup of hot boiling coffee, as this can melt the trashcan liner causing an unnecessary mess to cleanup. Please be respectful of the housekeepers and janitors.
- -Spills: If you see a spill, please try to clean it up immediately, if unable to then get a wet floor sign to display (they are readily available in all restrooms on each floor) and call the housekeeper for cleanup. We must all work together to prevent slips and falls.
- -Employees working in patient care areas, please be mindful of wearing long hair down. This is addressed in our personnel manual under dress code: As stated: "Hair should be clean and well-groomed; hair must be secured in a fashion that does not interfere with patient care, work function or safety."
